By virtue of an email we received on 27th November 2017 and the minutes of the General assembly held in early November 2017 which stated, "it was resolved to remove the Hong Kong Kennel Club [from 1st January 2019](#)". The relevant copies are now enclosed herewith so that every kennel club member could clearly see how FCI was running this association without legitimacy.

Reading from these two contradictory notices, this was once again a demonstration of how arbitrary FCI was handling their members' affairs. It was just a blatant illustration of an association not ruled and governed by their Statutes or Rules BUT ruled solely by a group of people with selfish motive. Even the resolution passed in the GA, which our Club would definitely protest against, could be totally neglected with no sound rationale to support.

We were also informed vide your email dated 15 January 2018 that our previous letter "would be discussed and answered after the GC meeting to be held end of February this year". We think you definitely owed our Club and the fellow members an answer under what statutory powers the immediate removal of our membership was valid with legal binding effect.
